Tournament Prospectus

1. **Name:** GS Paperboard & Packaging International Youth Table Tennis Invitational Championship 2018
2. **Sponsored by:** GS Paperboard & Packaging Sdn Bhd (OJI Group of Companies)
Organized by: Penang Table Tennis Association (PTTA)
3. **Objectives:** To foster friendship & unity and to promote the sport of table tennis.
4. **Rules:** The Championship shall be conducted according to the Rules of The International Table Tennis Federation (ITTF).
5. **Date of Competition:** 21st & 22nd July 2018 (Saturday & Sunday)
6. **Venue:** MSN / PTTA Training Centre, Gat Lebuah Macallum, Georgetown, Penang.
Waze: Penang Table Tennis Training Centre
7. **Events:** Team Event with players under 18 years old (Born on or after year 2000). Combination of Male & Female player is allowed.
8. **System of Competition:**
 - 8.1 Team Event:
Each team match shall be played in the following order :
Match 1 : Singles - Player's age under 15
Match 2 : Singles - Player's age under 18
Match 3 : Doubles - 1 player under 15 and 1 player under 18
Match 4 : Singles - Player's age under 15
Match 5 : Singles - Player's age under 18
 - 8.2 Matches shall be decided based on the best of 5 games.
 - 8.3 The match will end when either team has won 3 matches.
 - 8.4 Minimum of 4 players shall play in a match. Player of Match 1 and 2 shall NOT allow to play in the doubles match.

8.5 A team conceding a walk-over (due to the absence of player / players) in any of the individual matches **shall be deemed to have conceded a walk-over in that team match.**

8.6 The mode of competition shall be as follows:

Stage 1: All the participating teams shall be drawn into individual group. All teams shall then play a round robin competition to determine the position of 1 and 2 in their respective group.

Stage 2: The champion and runner-up from each groups shall play in a knocked-out format for quarterfinals, semifinals and final.

9. Registration of Players

9.1 There is no restriction to the number of players from one nationality.

9.2 A maximum of 6 players and a minimum of 4 players shall constitute a team.

9.3 Change of players is allowed before the commencement of the tournament.

9.4 A registered player is not allowed to re-register with another team.

10. Team Uniform & Shoes:

All team players **MUST** wear their team playing attires for all matches and also during the Opening and Prize Presentation Ceremony. During the play, only non-marking shoes / indoor table tennis shoes are allowed in the table tennis court. Failure to observe the dress / shoe rules, the player will not be allowed to play and the decision of the organizer will be final.

11. Entry Fee: USD 100.00 or RM 400.00 per team

12. Entries :

Entry forms with the appropriate fees to be forward to Penang Table Tennis Association before the closing date. Payment can be made by cash, cheque or bank-in to the Association's account. Please attach bank transaction slip if paid to PTTA account.

- 16. Jury:** A team of jury shall be formed to manage this tournament.
- 17. Disputes:** All matters of dispute shall be referred to the jury and the jury's decision shall be final and binding.
- 18. Protest:**
 - 18.1** All protest must be in writing, accompanied by a deposit of USD 300.00 and forwarded to the jury within thirty minutes from the occurrence of the incident. The match shall hence be played under protest.
 - 18.2** If it is resolved that such appeal / protest is unfounded the deposit shall be forfeited.
- 19. Other Matters:** The Organizer whose decision shall be final shall decide any matter not provided for in the foregoing regulation.
